CITY MANAGER:

CASP Inspections:

Inspector Victor Felix of California Certified Accessibility Specialists, Inc. (CALCASP) began his review of the 19 City facilities designated to aid in the preparation of the City's ADA (Americans with Disabilities Act) Transition Plan. Upon completion of this review and receipt of the report, Staff will begin preparation of the Plan.

New Proposition 47 Grant Cycle:

I met with Stakeholders and Matt Russell (former Grant-Writer) regarding the new Proposition 47 Grant Cycle. It was agreed that a single application to continue Restore Program Funding with an expansion to include "Transitional Aged Youth" (youth ages 18-26) will provide the best opportunity for continued funding.

Meeting with Paskenta Band of Nomlaki Indians (Tribe):

I met with representatives from the Tribe regarding Rolling Hills Clinic IV on January 30th.

Annual Debt Transparency Report:

California Government Code Section 8855(k) requires State and Local Issuers to submit an Annual Debt Transparency Report for any issue of debt for which they have submitted a Report of Final Sale on or after January 21, 2017. The Annual Debt Transparency Report is due to CDIAC within seven (7) months of the close of each reporting period which is defined as July 1 through June 30 annually. Issuers will continue to submit an Annual Debt Transparency Report to CDIAC on or before January 31st of each year until the later date on which the debt is no longer outstanding, or the proceeds of the issue have been fully spent. The Annual Debt Transparency Report for the water and sewer refinancing has been completed and submitted.

Potential Closure of West Street between Marin and South Streets:

Planner 1 Molly Marcussen, Fire Chief Tom Tomlinson and I will be meeting with the Corning Elementary School Superintendent to develop final plans for the potential closure of West Street between Marin and South Streets.

Meetings:

- January 25th: Attended the Sacramento Valley City Managers Department Meeting in Folsom and met with other regional City Manager's to discuss the Town of Paradise, their recovery and how we may assist with the benefits of Police/Community relations.
- Week of February 11th 15th: I will be attending the League of California Cities City Manager's Meeting as well as taking a few days off for a vacation. Chief Fears will be the Acting City Manager during my absence.

PUBLIC WORKS DEPARTMENT:

Energy Conservation Project:

Aircon Energy has continued to work on the Energy Efficiency Improvement Project. Installation of new LED lights have been completed at all City Buildings. The next phase of the project will start with the replacement of HVAC equipment at City Hall, heaters at the Fire Department and will end with the replacement of 3 well pumps.

ATP Safe Routes to School Projects:

The California Transportation Commission met on January 30, 2019 and adopted the 2019 Active Transportation Program which included the West Street School Connectivity Project and the Olive View School Connectivity Project totaling \$2.4 million in funding for new sidewalks, curbs, gutters, crosswalks and bike lanes in these areas.

POLICE DEPARTMENT:

Patrol:

In addition to responding to 208 calls for service, a total of 37 officer reports were taken and there were 147 officer-initiated incidents, including 89 traffic stops. Officers made 16 misdemeanor and 1 felony arrests. Officers issued 26 citations, of which; 17 were misdemeanors, and 9 were infractions during the period of January 23, 2019 through January 30, 2019.

Training:

Officers continue to participate in POST Portal Training and Lexipol Daily Training Bulletins. Other POST on-line training continues for Patrol and Dispatch personnel.

Vehicle Abatement:

Due to the continuing light-duty of CSO Robbins, no vehicle abatement has been initiated.

FIRE DEPARTMENT:

Call Volume:

The Corning Volunteer Fire Department responded to 16 calls for service last week; they consisted of 10 medicals, 2 fires, 2 traffic collisions, and 2 public safety calls.

Orland and Capay Fire:

Orland and Capay Volunteer Fire Departments responded to 14 calls for service last week; they consisted of 9 medicals, 2 fire, 1 traffic collisions, 2 public service calls.

Training:

Training for the Corning volunteers consisted of 26 members completing recertification of CPR (Cardiopulmonary Resuscitation).
