**WHEREAS**, at a consolidated General Election held in the City of Corning on November 6, 2018, with eight former City Precincts (Corning 1 & 2 - Pre, Corning 4, 5 & 7, and Corning 3, 6, & 8) consolidated into three, there was one candidate for the office of Mayor, Douglas Hatley Jr. Four candidates for the office of City Council Member, namely: David L. 
